- 2) Accumulation of combustible waste in and around the premises should be avoided.
- 3) The exit ways shall be always kept clear without any Obstruction.
- 4) Liquefied petroleum gas should not be stored in the building.
- 5) The doors shall not be kept locked / latched during working hours and shall be free from obstruction.
- 6) During the class hours the class room doors shall not be locked from inside to outside.
- 7) As per Honorable supreme court order all teachers and staffs shall be trained to handle safety equipment, initiate emergency evacuation and protect their students in the event of fire and other emergency and the school shall observe the fire safety day on 14<sup>th</sup> of every year by conducting fire safety drills with co-ordinate with fire service department.

Hence this "Fire Safety recommendation" is issued to "Jain Public School" Located at #37, Sangapura Village, Anegundi Road, Gangavathi, Gangavati Taluk, Koppal Dist. subject to strict adherence of the conditions as laid down in this Recommendations and to check the portable fire extinguisher & Hose reel hose, and to conduct drills periodically and the Management must not extend the height of the building beyond 15.0 meters. Subject to condition and compliance of the above recommendations in column-4 of serial-B within 3 months and compliance to undersigned.

The "Fire Safety recommendation" is valid for only one year from the date of issue and it is renewable.
