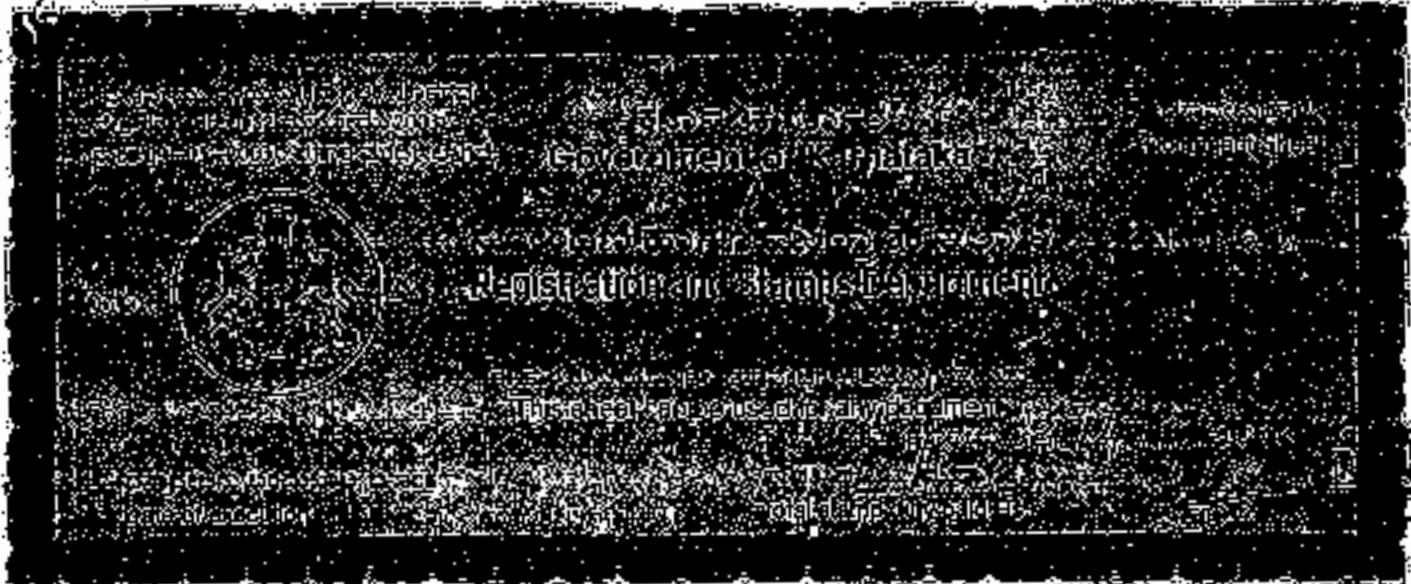

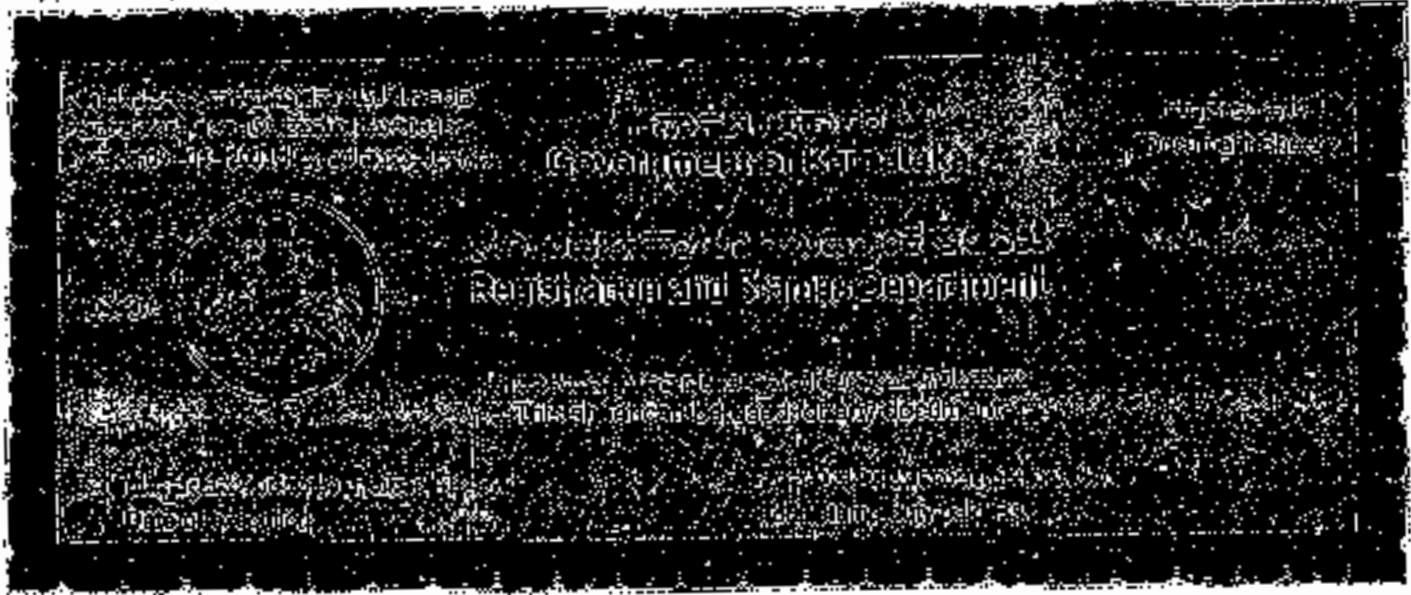

NOW THIS DEED WITNESSES AS FOLLOWS

- 1) The trust shall be styled and named as Arka Educational & Cultural Trust and it's Central Office shall be situated at No.91/2, Dr.A.N.Krishna Rao Road, V.V.Puram, Bangalore -560 044. The registered office of the Trust may be changed as may be decided by Trustees from time to time.
- 2) The Trust hereby created is not revocable at the Instance of the Author of the Trust at any time and under any circumstances.
- 3) The Author of the Trust has hereby transferred to the trustee a sum of Rs. ~~1000~~ (Rupees One thousand Only) in cash as nucleus to be held by the Trustees for the benefit and use of the Trust and has vested the same in the Trustees for the purpose of the Trust.
- 4) The main objects for which the Trust is created are:
  - a) To establish, Maintain, Run, develop, improve, extent, grant, donate for and to aid and assist in the establishment, maintenance, running, development, improvement and extension of hospitals, clinics, dispensaries, maternity homes and similar institutions affording treatment, cure, rest, recuperation and other advantages in the way of alleviating the suffering of humanity.
  - b) To start and run institutions for giving Medical Education, Nursing Education Para Medical Education and other institutions to give instruction and education in the medical and allied fields.

11) A member of the Board of Trustees may resign and such a member shall cease to be member upon the acceptance of his/her

12) The Board of Trustees shall have the power to amend the terms of this trust instrument only for the efficient and successful achievement of the objects of this trust by unanimous decision but however, no such amendment shall prove repugnant to the provisions of section 2(15), 11, 12, 13 and 80(13) of the Income Tax 1961 and also no such amendment shall be carried out without the prior approval of the Commissioner of Income Tax having the jurisdiction over the trust

13) The funds of the Trust shall be invested in the modes specified under the provisions of Sec. 13(1)(d) r.w.s. 11(5) of the Income Tax Act, 1961 and amended from time to time. The funds and the income of the trust shall be solely utilized towards the achievement of the objects and no portion of it shall be utilized for payment to trustees by way of profit, interest and dividend.

14) The benefits of the Trust shall be open to all irrespective of caste/creed/religion.

15) In the event of this Trust being dissolved the properties/funds of this trust shall go to any other Trust/Institution having similar objective and which enjoys recognition U/s. 80G and for any other relevant provisions of Income Tax Act, 1961 and in no case the asset/properties shall be distributed directly or indirectly among the Trustees or Authors if any.
